2. APPICATION REQUIREMENTS

- 1. Applicants who have completed at least 12 years of school education in their home countries, except Japan. And they should be at the age of 18 or older at the time of enrollment.
- 2. Applicants who are admitted by our school following Requirement 1.
- 3. Applicants who have α strong willingness to study and have clear goals.
- 4. Applicants who have learned Japanese more than 150 hours in their home countries and have achieved at least one of the following certificates.
- 5. Applicants who are healthy both mentally and physically, and can take care of their lives by themselves. The applicants need to submit Certificate of Health after passing the interview.
- 6. Applicants whose families have steady income and good financial conditions to support the expenses of studying abroad.

3. Application Method

During the application period, applicants or their agents need to submit the necessary documents to the school directly or by postal mail.

4. Notes on Application Documents

- ① Fill in the application documents such as application for admission, purpose for studying Japanese in Japan, and document of financial sponsorship with your own handwriting, or typing, and then put your own signature.
- ② If the documents are written in non-Japanese language, attach their Japanese translation with the name and telephone number of the translator.
 - If the documents are translated by an organization, the organization name, address, and telephone number must be entered.
- 3 The Certificates in application documents must be issued after September 1st of the previous year.
- Any corrections, including the using of correction fluid, are unacceptable. All rewritten documents are invalid.
- ⑤ All of the copy documents must be prepared on A4 size paper. Reduce them if the original is bigger.
- ⑥ If any instances of misrepresentation of facts are found, this will lead to the termination of admission.
- Please pay attention that if there is any kind of deficiency of the application documents (lacking of documents, contents missing, omission of seals / signature), your application will not be accepted.
- If your sponsor is living in Japan, or your caretaker is in Japan who prepares the paperwork for you, please bring the following documents and apply directly to the school with an appointment.
 - (1) Document of Financial Sponsorship (prescribed form)
 - (2) Certificate of Employment (If the sponsor is a president of company or is a self-employed business owner, a copy of corporate registration must also be submitted.)
 - (3) Certificate of Income and Tax Payment (issued by the government office)
 - (4) Certificate of Bank Balances
 - (5) Copy of Bank Book
 - (6) Certificate of Resident Status (All family must be entered in)
 - If the sponsor is a foreigner in Japan, a double-sided copy of Residence card is necessary.
 - (7) Document proving the relationship between the applicant and the sponsor
 - (Ex. copy of family resister, certificate of resident registration, relative notarization, etc.)
- 9 Other documents may be asked for if necessary.
- After being reviewed by the Immigration office, we will not return the documents except the original certificate of graduation and transcript, so if you would like to take back any other documents, please clearly notify us on the time of submission.
- ① The sponsor will bear not only all the responsibilities of the applicant's tuition and living expenses, but also the responsibilities of the applicant's school life and personal problems, etc. during the time the applicant is a student of our school.
 - If the sponsor is living in Japan, he/she should be an independent employed individual and have a stable income.

<The other expenses — "National Health Insurance">

It is a medical insurance program that foreigners living in Japan for one year or more have to buy. 70% of the treatment expenses will be paid by this insurance, and the participants pay the remaining 30%. For foreign students, the insurance costs about 22,000 yen for one year. After entrance, the procedure at ward office is necessary.



8. Others

1. Living Expenses in Japan

- ① About 120,000 yen (included housing rent) per month is required to as average living expenses besides the school tuition.
- ② You had better prepare sufficient fund because it is difficult to earn all living expenses with part time jobs.
- ③ It is best to bring cash about 600,000 yen as living expenses for six months when you come to Japan.

2. Part Time Jobs

Part time job is basically prohibited by the law under the status of "studying abroad".

Therefore, when a foreign student works part time using leisure time, "Permission of Other Activities" from the Immigration Bureau is required.

3. Dormitory

- ① In order to provide a stable learning environment, the school prepares a dormitory for students who applied.
- ② You need to pay about 300,000 yen at least as an initial cost.
- ③ If you plan to live with a family or relative in Japan, please inform us of this in advance.

 We might conduct an interview with the person you plan to live with. At the same time, the person will need to submit a document of guarantee.
